

Minutes of Regular Meeting Held April 16, 2025

The regular meeting of the South Kalamazoo County Fire Authority Board was held at 11318 N. Boulevard, Vicksburg, Michigan on April 16, 2025. The meeting was called to order by President Chairman Mike Tomlinson at 6:00 pm.

Approval of the Agenda.

Gatlin moved, seconded by Smith to approve the agenda as presented. Motion carried 6-0.

Citizen's Time -

Firefighter Moyer, member since 2015 voiced serious concerns about its current direction, highlighting a shift in focus toward budgets and superficial spending at the expense of critical needs. Despite being one of the busiest departments in the county, it suffers from outdated equipment, undercompensated staff, and unqualified personnel. A recent near \$1 million purchase of an impractical tanker truck, which replaced a functioning engine, exemplifies poor decision-making. The tanker is outdated and unsafe for its intended use. The department also struggles with substandard working conditions, including faulty gear and deteriorating buildings. FF Moyer calls for a meeting with HR to urgently address fleet readiness, staffing qualifications, and overall safety—stressing that continued neglect is unacceptable and dangerous.

Commissioner John Gisler- A new committee of intergovernmental units is being formed, involving 25 different government units in the county. The committee aims to meet at least quarterly. A small organization meets on the second Monday of each month. Upcoming meetings include discussions on the Palisades plant on May 12, 2025 at the Career & Tech Center, please let me know if you are interested in attending, and lastly domestic terrorism concerns on June 9th at Mark's Diner at 8:30am.

Old Business:

- a. 15-2 Roof Repairs & Proposed Village of Vicksburg Lease Discussion with the Vicksburg Village Manager about possibly having Vicksburg Village pay for the roof repairs. Fredricks has also reached out to the top 2 making sure their proposals are still the same amount. Work would start in June now instead of May.
- b. Quarterly & Annual Audit Quotes- Jeff will be doing the Audit May, and hoping to have the proposed audit to us for May meeting.
- c. Legal Counsel- Keller Moved, seconded by Smith to move forward with Fahey Schultz Burzych Rhodes as legal counsel and have Dee contact them for a contract. <u>Roll Call 6-0.</u>
